Case study overview	<p>Jeanette is an arborist who has been married before. She’s well aware it was a mistake, as she’d always known she was gay, but she was young and has no regrets. She never bothered to get divorced though, until she decided she wanted to marry Helen. She met Helen on a dating website for women who love women, and as soon as they met in person, she was drawn to Helen’s no-nonsense approach to life.</p> <p>Helen is a landscape gardener, so when she found out Jeanette was an arborist, she thought it was clearly meant to be. She runs her own business designing and creating beautiful gardens for people’s homes, and she loves spending her days outside.</p> <p>Ever since they met they’ve spent every weekend possible exploring the countryside in their 4WD and camping under the stars. They have a plan to visit every suburb and town in Victoria together, and they’re gradually ticking off the very long list. Helen is a keen photographer and loves finding new rock formations, animals and plants to photograph. She’s pretty talented too!</p> <p>Helen and Jeanette have been together for eight years, and they’re thrilled that since the law changed in December 2017, they can finally legalise their commitment to each other. They got engaged on 15 November 2017, the day the results of the postal survey were announced, and started planning their wedding as soon as the marriage equality legislation was passed. However, their wedding needs to be brought forward from their original planned date, as Helen’s father is very ill, and his doctors predict he has less than three weeks to live. They would like to marry in 11 days’ time and need your help to apply for a shortening of time. They would like the ceremony to take place in the hospital chapel.</p> <p>When they come to see you to complete the NOIM, Jeanette lets you know that she is waiting for her divorce order to come through, and expects it will be emailed to her some time the day after you meet to complete the NOIM. The application of DAVID ERNEST WATSON and JEANETTE TRACI POWELL for a divorce order in relation to the marriage of the above named husband and wife, which was solemnised on the twenty-fifth day of February 2000, was heard on the fifth day of March 2020.

NOTES:

1. If a party to the marriage proposes to make an application to a court exercising jurisdiction under the *Family Law Act 1975* as to the property or as to the maintenance of that party, such application must be made within 12 months from the date upon which this divorce order takes effect. After that time such an application cannot be made without first obtaining the leave of the court to do so.
2. A divorce order which has taken effect may revoke, or otherwise affect the operation of, the Will of a party. Parties should seek legal advice about their position under the law of the State or Territory concerned.
3. A party to a marriage who marries again before this divorce order takes effect (unless the other party has died) commits the offence of bigamy.
4. If, before this divorce order takes effect, it comes to the notice of a party to the marriage that the other party has died, he or she should file an affidavit or certificate in the office of the court giving particulars of the date and place of death.



Case study overview

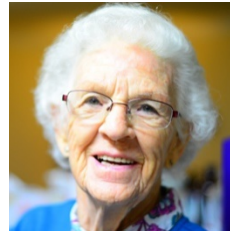

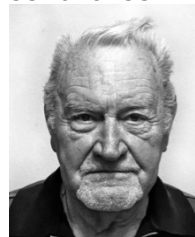
